Invitation for Quotation
(For Supply of Miscellaneous Items)

Sealed quotations are invited from the intending registered firms/dealers/ Govt. order suppliers for entering into Annual Rate Contract and supply of Miscellaneous Items, stationery items, computer peripherals and electrical items for use in the office of the District Legal Services Authority, Golaghat for the year 2022-23. The intending firms must submit their quotations in sealed envelop to the undersigned on or before 02.09.2022 during the working hours.

General Terms & Conditions

1. The sealed quotation shall be super scribed as 'Quotation for supply of Miscellaneous Articles' and should contain the following documents:

- (a) Copy of PAN Card.
- (b) Copy of GST Registration Certificate.
- (c) Up-to-date Income Tax clearance certificate.
- (d) Up-to-date GST clearance certificate.
- (e) Copy of Trade License in Assam.
- (f) Copy of FSSAI certificate.

Each page of the documents should be signed by the bidder, with seal, on each page of each document, to establish the Bidder's eligibility to the bid & his qualification to perform the supply material if his bid accepted. In the absence of any of the above documents/ information, the offer may be summarily rejected without making any further reference in this regard.

The sealed envelope should be addressed to the District & Sessions Judge-cum-Chairman, District Legal Services Authority, Golaghat, Assam, Golaghat.

1. The rate should be quoted with GST and without GST separately.

2. Conditional quotations/tenders are liable to be rejected.

3. In case of violation of terms and conditions of the quotation/tender document or unsatisfactory supply of material or of poor quality and below standard, the undersigned reserves the right to terminate the supply order by giving intimation to the supplier/contractor.


4. Payments shall be made after satisfactory execution of the order and supply of material in satisfactory condition on bill basis. Payment of the material supplied under purchase order will be paid on receipt of complete consignment and checking of the material and on production of following:

- a) Invoice in triplicate,
- b) Delivery Challan duly signed by the consignee.

5. In case of successful bidder supplier's sub-standard materials, its tender shall be cancelled. Thereafter, next successive bidder may be considered.

6. In case of supplying of refreshment items (Food items) to the various programmes of DLSA, Golaghat, quality of food items should not be compromised and ensuring the food is hygienic falling which the contract will be deemed to cancellation. The tender party should have the ability to supply food as and when required on emergency basis. The party will bear the responsibility to clean up the venue after programmes.

No further communication shall be made in this regard except the selecting firm. The quotation should reach the undersigned on or before 3 P.M. of 02.09.2022 & no quotation/tender will be received thereafter.


