Applications are invited from eligible candidates within the age limit of **18 to 38 years** (Relaxation as per Govt. rules) for filling up **2 (two)** posts of **Peon** and **1** Post of **Driver** which are newly created under the establishment of the Additional District & Sessions Judge, Golaghat.

The details of Posts and Establishment:

- The applicants must submit their applications in the Standard Form of application published in the Assam Gazette Part – IX with self attested photocopy of caste certificate (if any), self attested copy of Driving License (Only for candidates applying for the post of Driver) and one recent passport size photograph.
- **For the post of Peon**, the selection will be carried out in 2 phases,
 - Written test: Multiple choice questions carrying maximum marks of 50. Admit cards will be issued to applying candidates to appear in the written test.
 - Personal interview: Candidates, who qualify in the written test, will be called for the personal interview. A list of successful candidates

will be published in the website of Golaghat District Judiciary website <http://golaghatjudiciary.gov.in/>

- No other document/testimonials should be submitted along with the application form. However, candidates will have to produce the testimonials in original, in terms of his/her Age, Caste, and Educational Qualification etc. during personal interview, after qualifying the written test.
- **For the post of Driver**, There will be a Skill Test along with the personal interview, for which admit cards will be issued to the applying candidates.
 - A candidates will have to produce the testimonials in original, in terms of his/her Age, Caste testimonials in original, in terms of his/her Age, Caste, and Educational Qualification etc. in the event of being selected. Failing which, his candidature will be summarily rejected and the next eligible candidate from the merit list will be considered.
- Completed applications along with all testimonials as mentioned above should be addressed to "The District and Sessions Judge, Golaghat, PIN 785621, Assam" and should be dropped in the "Drop Box" Labeled as " Drop Box for Applications" to be kept at the premise of Office of the undersigned within the stipulated date & time.
- **Last date of receipt of application in the "Drop Box" is 16.03.2015 upto 4.15 pm. Drop box will be closed after last date and time.**
- Application submitted in any other mode, except as indicated and incomplete applications will be summarily rejected without any communication to the candidate.
- **Canvassing by any means will immediately lead to rejection of candidature.**
- Candidates who are already in the Government services must submit "No Objection Certificate" from appropriate authority at the time of interview.
- Selected candidates will receive their appointment letters by post at their respective postal address as specified by them in their application form.

- Reservation of candidates belonging to different categories will be as per rules.
- The certificate for claiming reservation must be issued by the competent authority and the same in original must be produced before the selection committee at the time of interview.
- Experience in the relevant field will be counted.
- The office of the undersigned reserves the right to alter/modify or change any of the terms and conditions including selection criteria etc. mentioned in the advertisement.
- The admission of candidates at all stages of the selection process will be purely provisional and subject to their satisfying the prescribed eligibility conditions by way of furnishing documentary evidence in support thereof. If on verification at any time before or after the selection process, it is found that a candidate does not fulfill any of the eligibility condition, his/her candidature shall stand cancelled. Mere calling of candidate to the written test/ skill test/interview does not necessarily mean acceptance of candidature.
