ORDER

Dated 30-08-2022

In pursuance of Hon'ble Gauhati High Court letter No. HC-VII-76/2019/2939/AC, Dated 07-05-2021 and letter No. HC-VII-76/2019/2162/AC, Dated 16-08-2022 and as per the Tender Notification dated 07-07-2022 issued by this office for outsourcing a vehicle, the bidder namely Sri Bipul Sharma, Mahasweta Event Management & Travel Agency, Dergaon, Golaghat is accepted for providing a brand new Hyundai Verna SX on outsourcing basis, to be used by the Ld. Addl. District & Sessions Judge, Golaghat, as per the following terms and conditions.

1. The selected bidder is requested to handover the Vehicle in the office of the undersigned along with copy of necessary documents relating to the Vehicle, i.e. Registration Certificate, Insurance Certificate, Pollution Certificate, Road permit etc. immediately (Preferably by first week of September, 2022) from the date of issue of this order.
2. The maintenance of the Vehicle including change of mobil, coolant and other lubricants, repairing of any defects, payment of all type taxes etc. shall be borne by the registered owner. However the expenses of fuel shall be borne by the user.
3. The registered owner will take minimum reasonable time for causing the repairing works of the vehicle, if required.
4. The contract period will be initially for 1 (One) year from date of receiving the vehicle by the office of the undersigned.
5. Payment will be made, as per Govt. Norms, after submission of Bills @ Rs. 25,800/- per month for the Vehicle.
6. Legal jurisdiction of any dispute will be within Golaghat District.
7. The price quoted by the bidder shall remain fixed during the entire period of contract.
8. The District & Sessions Judge, Golaghat reserves the right to terminate the contract with bidder, within the contract period, at any stage, if the service is not found satisfactory after giving two weeks notice to the bidder, in writing.
9. Payment of any Govt. Tax/Duty for plying the vehicle shall be paid by the bidder.

10. Income tax will be deducted from the hire charge of the bills as per the Income tax norms (if any)
11. Toll tax, if any, shall be borne by the user.
12. In case number of breakdown exceeds three times in a particular month, the vehicle may be withdrawn and will be replaced, with another one, by the bidder.
13. The bidder will be allowed to undertake servicing of the vehicle on a holiday once in a month, if required.
14. On all other days, the vehicle will be stationed at the office/residence of the Ld. Judicial Officer to whom the vehicle is allotted and same can be moved only by the order of user.
