1. The candidates must be an Indian citizen as defined in Article 5 to 8 of the Constitution of India
2. The candidates must not be less than 18 years and more than 38 years of age as on 01.01.2020. The upper age limit is relaxable by 5 years for SC/ST candidates and 3 years for OBC/MOBC candidates)
3. Minimum Qualification is Class VIII pass and candidates must have valid Professional/Transport Driving License.
4. If any candidate is found to have suppressed his educational qualification or given any wrong information at the time of applying for the post, his candidature shall be liable to be rejected.
5. The applicant must clearly mention on the envelope against which post he has applied for. If any candidate applies for both, separate applications have to be submitted in separate envelopes indicating the post he has applied for on the envelope.
