**ADVERTISEMENT FOR SELECTION OF PARA LEGAL VOLUNTEERS (PLVs)**

Dated: 05.03.2020

Applications are invited from the eligible local residents of the Golaghat District only for Selection as Para Legal Volunteers (PLVs) in the following format. The selection shall be made on the basis of viva-voce test comprising 30 (thirty marks).

**AGE:** Minimum 18 (Eighteen) years as on 01-01-2020.

**ELIGIBILITY:**

- PLVs shall be literate, preferably matriculate, with a capacity for overall comprehension.
- Teachers (Including retired teachers).
- Retired Government servants and senior citizens.
- M.S.W. Students and Teachers.
- Anganwadi Workers.
- Doctors/Physicians.
- Students & Law Students (till they enrol as lawyers).
- Members of non-political, service oriented NGOs and Clubs.
- Members of Women Neighbourhood Groups, Maithri Sanghams and other Self help Groups including of marginalized/ vulnerable groups.
- Educated prisoners with good behaviour, serving long term sentences in prisons.
- Any other person whom the District Legal Services Authority or Taluk Legal Services Committee deems fit to be identified as PLVs.

**DISQUALIFICATION:** The PLVs shall be disqualified & removed from the Panel: -

- If he/she fails to evince interest in the Scheme.
- If he/she has been adjudged insolvent.
- If he/she has been accused of an offence.
- If he/she has become physically or mentally incapable of acting as PLVs.
- If he/she has so abused his/her position or misconducted in any manner as to render his/her continuance and prejudicial to the public interest.
- If he/she is an active political enthusiast of a political party.

**REMUNERATION:**

The work of PLVs do not carry any salary, remuneration or wages except honorarium fixed by the Assam State Legal Services Authority or National Legal Services Authority from time to time which is at present Rs.500/- (Rupees five hundred only) per day for performing of any legal services activity.

**JOB- PROFILE:**

PLVs do not look up to the income they derive from their services as PLVs, but they should have a mind set to assist the needy in the society coupled with compassion, empathy and concern for the upliftment of marginalised and weaker section of the Society. They must have unflinching commitment towards the cause which should be translated into the work they undertake. They will have to organise

legal services awareness camps, perform door-to-door campaign, guiding the local people in getting access to justice.

**PROCESS OF SUBMITTING APPLICATION:**

1. The Intending Applicant shall fill up the Enclosed Format in his/her own hand legibly or by typing in Block Capital Letters.
2. The candidate shall annex self-attested photocopy of the relevant testimonials regarding his/her age, Educational Qualification, Nationality & Residential Status.
3. The candidate must bring all documents and testimonials in ORIGINAL at the time of viva-voce test.
4. The top of the envelope containing the Application shall be superscribe in **BOLD LETTERS "APPLICATION FOR PARA LEGAL VOLUNTEER UNDER D.L.S.A GOLAGHAT"**.
5. The Application Form shall be affixed with 3(three) Passport size photographs of the Candidate of which one should be affixed in the format and the rest 2(two) photographs shall be Enclosed with the Application Form.
6. One self addressed envelope with Rs. 10/- (Rupees Ten only) postal stamp shall also have to be submitted along with testimonials.
7. The Application must be addressed to the Secretary, District Legal Services Authority, Golaghat, Magistrate Colony, Stadium Road, PO & Dist- Golaghat, PIN-785621, Assam.
8. The job of PLVs are for rendering service to the society on voluntary basis and as such it does not entitle him/her for being regularized in Government Service.
9. Last date of submitting of Application is within 15 (fifteen) days from the date of publication of the advertisement within office hours i.e. (5 PM) positively.
