**ORDER**

In pursuance of the Assam State Legal Services Authority's letter No. ASLSA.212/2020/6 dtd. Guwahati, the 03<sup>rd</sup> February, 2020 and on the recommendation of Selection Committee for the selection of Front Office Coordinator, **Smti Runali Duarah, Roll No. 13**, D/o Sri Dilip Kr. Duarah, resident of Vill. Naharani, Sarupathar, Dist – Golaghat, Assam, Pin No. 785601 is hereby temporarily engaged as Front Office Coordinator in the Office of District Legal Services Authority, Golaghat, Assam on contractual basis at a consolidated pay of Rs. 20,000/- (Rupees Twenty Thousand only) pm. payable from the NALSA Fund subject to receipt of satisfactory Police Verification Report and Medical Fitness Certificate from the concerning department(s).

The engagement of the Front Office Coordinator shall be for a period of one year only under the following terms and conditions:-

1. The salary of the Front Office Coordinator shall be paid by the DLSA from the NALSA Fund.
2. After expiry of the contract period of 01 (one) year, the contractual agreement will automatically stand terminated.
3. If the service of the Front Office Coordinator is required beyond the contractual period of one year, the District Legal Services Authority may re-engage the said contractual staff afresh for such other period, which shall not exceed one year at a time, subject to the approval of the Hon'ble Executive Chairman, Assam State Legal Services Authority.
4. The appointment is purely temporary and on contract basis and does not entitle the person for being regularised in Government Service.
