1. Restriction of all Judicial Court under the Judgeship is hereby further extended till 30th of June, 2020 in continuation to the earlier Order No. DJ(G)2492-98/2020 dated 24-03-2020 and Order No. DJ (G) 2526-35/2020.

8. The cases of the Court of the SDJM (M), Sarupathar and Munsiff cum JMFC, Sarupathar will be taken up from the **Virtual Court No. 5** (i.e. Court Room of the SDJM(M), Sarupathar)

9. The matters which are already fixed till 30th of June, 2020 in all the Courts under this Judgeship shall stand deferred except those appearing in the cause list uploaded in the official website.
10. In case of any Ld. Advocate wants to submit any hearing/submission etc. from their own arrangement through Laptop/Desktop by using "Vidyodesktop" app., they are requested to contact the Nodal Officers of each establishment before 2 days of their submission. Accordingly a link will be sent to the concerned Advocate from this establishment for hearing/submission etc.
