Asstt. presently working as Copying in-charge & Protocol duty in the office of the District & Sessions Judge, Golaghat is entrusted to maintain the stationary files, purchase and disburse of stationary articles of the office as required by the office. Further he shall also maintain the official vehicles, Xerox machine, Lithu Machine, Computer, Generator and Water Pump Machine and also maintain the afore said files in addition to his normal duty.

(5) Shri Rose Ali, office peon who assist Bench Asstt. of MACT, Golaghat is transferred to the office of the Munsiff (M), Dhansiri, Sarupathar in the same capacity vice Shri Paban Bori transferred.

(6) Shri Paban Bori, Peon office of the Munsiff (M) -cum- JMFC, Dhansiri, Sarupathar is transferred to the District & Sessions Judge, Golaghat in the same capacity and to assist the Bench Asstt. of MACT Bench.
