Member Secretary, ASLSA regarding implementation of NALSA's protocol for Early Access to Justice at Pre-arrest, Arrest and Remand Stage.

In this connection, Secretary, DLSA, Golaghat discussed with the members about the proposal of NALSA to put up Hoardings enumerating rights of persons at pre-arrest, arrest and at remand stage including the right to avail free legal aid from Legal Services Institutions and phone numbers and addresses of DLSAs/TLSCs at public places, particularly at police stations, post office, etc, in coordination with local authorities. He also imparted information in brief about the Scheme i.e. Early Access to Justice at Pre-arrest, Arrest and Remand Stage and sought help in installation of the hoardings from the members.

The Addl. Superintendent of Police (HQ), Golaghat and special invitee Sri Polash Goswami, Postmaster Golaghat HPO have agreed to provide all feasible help in putting up hoardings for awareness of general public.


