DISCUSSION ON AGENDA NO. 1

Ld. Secretary, DLSA, Golaghat has placed before the committee the final orders passed by him in connection with following inquiry cases of victim compensation, and thereafter the members present had passed its decision as shown against each of the cases.

Secretary has given its final report stating that after considering all facts & circumstances emanated from the inquiry as well as the physical and mental trauma faced by the victim, to grant her interim compensation from the WVCF.	The members have unanimously approved the final order of the Secretary after giving due consideration to the facts and circumstances of the case and ordered to pay ₹50,000/- (Rupees Fifty Thousand) only as interim compensation to the victim girl from the Women Victim Compensation Fund.
