Secretary, Golaghat has put up before the members of the District Authority the following record of Victim Inquiry case and accordingly the members have unanimously passed their decision as shown against the name.



1	V.C No. 5/2021 arising out of petition No. 05/2021 dtd. 01.07.2021. [Dergaon P.S. Case No. 226/2021 u/s 375 (L) IPC]	On 05.10.2021 Secretary, DLSA passed an order stating that, since victim is a deaf and dumb as such she cannot take care of herself without the support of her father who is a petty day labour. Considering the toll on the health of victim because of unwanted pregnancy and subsequent giving birth of a baby, the victim required to be adequately compensated for her as well as for her child's rehabilitation.	Members after perusing the facts and circumstances of the case have unanimously decided to grant interim compensation of Rs. 50,000 (Rupees fifty thousand only) to the victim.

With this discussion this meeting ends with a vote of thanks to the Chair.




