**DISCUSSION & RESOLUTION**

At the outset, the Hon'ble Chairman, DLSA has informed the members that National Lok Adalat will be held on 10.7.2021 in both physical and hybrid mode and as such sought for cooperation from the members present. Hon'ble Chairman has requested the District Administration to submit the eligible cases before the DLSA, Golaghat for disposal in the Lok Adalat.

"The 6 point guiding Scheme" received from the ASLSA vide No. ASLSA.93/2017/400 dated 30.6.2021 has been discussed in the meeting. The Police Administration Golaghat has consented to give relaxation to the persons who remain on duty for Lok Adalat or are attending the Lok Adalat from the rigorous of restricted movement imposed by the district administration subject to their production of Identity Card or Lok Adalat Notice. Even though endeavor is on to restrict people's physical attendance before the court on 10.7.2021 still there exist a scope of assembly of litigant at the Court premises and as such Addl. S.P.(HQ) has to look after regulating such assembly so that social distancing norms may be adhered to. Since, Bokakhat sub-Division is under complete lockdown as such special care need to be taken for Bokakhat Sub-Division.
